

Dollar General Survey Sweepstakes 2023 OFFICIAL RULES

NO PURCHASE OR PAYMENT OF MONEY IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT OF MONEY WILL NOT IMPROVE THE CHANCES OF WINNING. THE SWEEPSTAKES AND ALL ENTRIES ARE SUBJECT TO ALL FEDERAL AND STATE LAWS AND REGULATIONS. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

The Dollar General Survey Sweepstakes 2023 (the "Sweepstakes") is intended for legal residents of the United States of America ("USA") and shall only be construed and evaluated according to applicable USA law and applicable state law. Do not enter this Sweepstakes if you are not a USA resident or are otherwise ineligible to enter in accordance with these Official Rules at the time of entry.

SPONSOR/ADMINISTRATOR: The Sweepstakes is sponsored by Dollar General Corporation, 100 Mission Ridge, Goodlettsville, TN 37072 (the "Sponsor") and administered by American Sweepstakes & Promotion Co., Inc., 300 State St., Suite 402, Rochester, NY 14614 (the "Administrator").

ELIGIBILITY: The Sweepstakes is open and offered only to legal USA who are at least eighteen (18) years of age at the time of entry. Employees, officers and representatives of the Sponsor, Service Management Group ("SMG"), the Administrator, their respective parent companies, employees, officers, directors, subsidiaries, affiliates, distributors, sales representatives and advertising and promotional agencies, and the officers, directors, agents, and employees of each of the foregoing (collectively, the "Released Parties"), and members of their immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are NOT eligible to participate in this Sweepstakes. Two (2) methods of entry are as follows:

- 1) *ONLINE SURVEY* – Entrants may make any purchase from a participating Dollar General store within the fifty (50) United States and the District of Columbia, visit www.dgcustomerfirst.com or www.dgxcustomerfirst.com (“Website”), and follow the instructions to enter the unique code printed on the Entrant’s Dollar General store purchase receipt, complete a survey, and provide entrant’s first and last name, phone number, and email address. After the completion of the survey and submission of Entrant’s information at the Website, an Entrant will receive one (1) entry into the applicable Entry Period (based on the date in which the survey is completed).
- 2) *ALTERNATE METHOD OF ENTRY*: To enter without making a purchase, an Entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, and date of birth (MM/DD/YYYY) on a 3½”x5” card (“Mail-In Entry”) and mail it with sufficient postage to: Dollar General Survey Sweepstakes, PO Box 970, Macedon, NY 14502-0970. A Mail-In Entry must be postmarked by the Entry Period End Date and received by the Mail-In Entry Received by Date (as defined above) to be eligible for the applicable Entry Period. An

Entrant will receive one (1) entry into the applicable Entry Period for a valid Mail-In Entry. Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, Mail-In Entries mailed in envelopes or sent in excess of the entry limits set forth below will not be accepted. A Mail-In Entry received without a verifiable and legible return address will be deemed incomplete and not valid.

Limit one (1) entry per Entrant per Entry Period, regardless of the method of entry. The Sponsor reserves the right to disqualify any Entrant that submits more than the maximum allowed entries. All required information must be provided to enter and to be eligible to win. Incomplete entries will be disqualified. By participating in the Sweepstakes and providing any personal contact information, Entrants hereby agree to Sponsor's collection and usage of their personal information and acknowledge that they have read and accepted Sponsor's Privacy Policy.

GENERAL CONDITIONS: If for any reason the operation or administration of this Sweepstakes is impaired or incapable of running as planned for any reason, including but not limited to (i) infection by computer virus or bugs, (ii) tampering or unauthorized intervention, (iii) fraud, (iv) technical failures, or (v) any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, the Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes in whole or in part, at any time, without notice and award the applicable Prizes (defined below) using all non-suspect eligible entries received as of, or after (if applicable) this cancellation, termination, modification or suspension date, or in any manner that is fair and equitable and best conforms to the spirit of these Official Rules. Sponsor reserves the right, at its sole discretion, to disqualify any individual deemed to be tampering or attempting to tamper with the entry process or the operation of the Sweepstakes or Sponsor's Website; or acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner.

associated with the registration in question. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider or other organization (e.g., business, educational, institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event shall the Released Parties be liable for attorney fees. DRAWING AND NOTIFICATION: All potential Prize Winners will be selected in fifty-six (56) random drawings from among all eligible entries received by the Administrator whose decisions are final and binding. The Prize drawings will be conducted on or about the dates listed above. There will be ten (10) potential Prize Winners selected in each Entry Period’s Prize drawing. Odds of winning a Prize will depend on the total number of eligible entries received DURING THE ENTRY PERIOD IN QUESTION. Note: Entries will not carry over into the subsequent Entry Periods. All potential Prize Winners will be contacted by the Administrator via phone, email and/or a USPS mail package of Prize confirmation.

PRIZES & PRIZE CONDITIONS: There will be five hundred sixty (560) Prizes available throughout the Sweepstakes Period. Each Prize Winner (“Winner”), upon the Administrator’s verification of eligibility, will receive one (1) \$100 Dollar General Gift Card (“Prize”). A Dollar General Gift Card is subject to all terms and conditions set forth on the card. Total Prize Pool - \$56,000. Limit two (2) Prizes per person.

By accepting a Prize, the Winners agree to release and hold harmless the Released Parties from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of the Prize. Each potential Winner is subject to verification of eligibility and compliance with these Official Rules. Potential Winners will be contacted by Administrator via email or phone call and will be required to provide their complete mailing addresses within three (3) calendar days of notification. Please allow six (6) to eight (8) weeks after verification for Prize delivery. DISPUTES: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of Entrants, Administrator, and Sponsor in connection with the Sweepstakes shall be governed by and construed in accordance with the laws of the State of Tennessee, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's or jurisdiction's laws. By participating in the Sweepstakes, Entrant agrees that: (i) any and all disputes, claims, and causes of action arising out of or in connection with the Sweepstakes, shall be resolved individually without resort to any form of class action; (ii) any judicial proceeding shall take place in a federal or state court within the State of Tennessee; (iii) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event will attorney fees be awarded or recoverable; (iv) under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to seek, punitive, incidental, exemplary, consequential, special damages, lost profits, other damages, and/or any rights to have damages multiplied or otherwise increased; and (v) Entrant's remedies are limited to a claim for money damages (if any) and he/she waives any right to seek injunctive or equitable relief.

SEVERABILITY: The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. If any provision of the Official Rules is determined to be invalid or otherwise unenforceable, the other provisions will remain in effect and will be construed as if the invalid or unenforceable provision were not contained herein.

MISCELLANEOUS: These Official Rules contain the full and complete understanding with respect to the Sweepstakes and supersede all prior and contemporaneous agreements, representations and understandings, whether oral or written. The headings herein are for convenience only, do not constitute a part of these Official Rules, and shall not be deemed to limit or affect any of the provisions hereof. No amendment to, or waiver of, any provision of these Official Rules shall be effective unless in writing and signed by both Sponsor and Administrator. The waiver by Sponsor or Administrator of any provision of these Official Rules shall not constitute a waiver of any other provision herein. The rights and obligations hereunder may not be assigned by Entrant, whether by operation of law or otherwise, without the prior written consent of Sponsor, and any attempted assignment in violation of the foregoing shall be null and void. These Official Rules shall be binding upon, and inure to the benefit of, the permitted successors and assigns of Sponsor, Administrator, and Entrant.
