## **DOLLAR GENERAL SURVEY SWEEPSTAKES**

## **OFFICIAL RULES**

## NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Dollar General Survey Sweepstakes ("Sweepstakes") is sponsored by Dollar General Corporation, 100 Mission Ridge, Goodlettsville, TN 37072 ("Sponsor") and is administered by Prize Logic, LLC, 25200 Telegraph Rd., Suite 405, Southfield, MI 48033 ("Administrator").

After the completion of the survey and submission of entrant's information at the Website, an entrant will receive one (1) entry into the applicable Entry Period (based on the date in which the survey is completed).

**B.** Alternate Method of Entry: To enter without a purchase, an eligible entrant may visit https://alternatemethodofentry.com/013343 and complete and submit the registration form. Then follow the links and instructions to save the registration form as a PDF with the barcode present. Then email the PDF to <a href="mailto:AlternateEntry@prizelogic.com">AlternateEntry@prizelogic.com</a> by the respective Entry Period end date to be eligible for the applicable Entry Period. An entrant will receive one (1) entrant into the applicable Entry Period for a valid entry via this method.

IMPORTANT: If using a mobile device to participate in the Sweepstakes, data rates may apply. Not all mobile telephone providers carry the service necessary to participate in this Sweepstakes. Entrants should consult their wireless providers' pricing plans.

**Limit:** Regardless of the method of entry, limit one (1) entry per entrant per Entry Period. Entries received in excess of the entry limit will be invalid.

- **4. RANDOM DRAWINGS:** On or about each Drawing Date listed in Section 1, the Administrator will randomly select ten (10) potential prize winners from all eligible entries received during the applicable Entry Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.
- 5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:
  - A. Prizes (520 total; 10 per Entry Period): Each winner will receive one (1) \$100 Dollar General Gift Card ("Prize"). A Dollar General Gift Card is subject to all terms and conditions set forth on the card. Five hundred twenty (520) Prizes will be available in the Sweepstakes (ten [10] per Entry Period). The ARV of each Prize is \$100.
  - B. Total ARV: The total ARV of all Prizes available in the Sweepstakes is \$52,000.
  - **C.** Odds of Winning: The odds of winning a Prize depend on the total number of eligible entries received during each Entry Period.
